IV. New Business

- Cybersecurity and Infrastrucutes Security Agency (CISA) Presentation Steve Neal -Protective Security Advisor
 - There are 16 Critical Infrastructure Threat Topics
 - There are 4 areas CISA cybersecurity, communications, chemical
 - PSAs work w/ State, Local, Tribal and Territorial as a link to CISA infrastructure protection
 - Assist visit talk about what security concerns you have
 - SAFE tool a security assessment tool used to see current posture and identify options for facility owners/operators to mitigate threats.
 - Infrastructure Survey Tool a web-based tool that applies weighted scores to identify vulnerability and trends across sectors. Physical, security force, management, info sharing, protective measures, dependencies
 - Infrastructure Visualization Platform data collection and presentation medium. Like a map of your facility
 - All of the resources are at no cost to the facility.
 - Regional Resiliency Assessment Program (a 3-year project) Idaho did a refined fuels supply resiliency assessment, WA is doing a last-mile refined fuels RRAP and public safety answering point PSAP. There will be a workshop in 2025 regarding the emergency fuel plan.
 - Protected Critical Infrastructure Information they have a program where they can't release the information received from agencies.
 - CISA.gov they provide training, and it is free
 - CISA also produces infographics regarding security concerns
 - They have communication services Wireless Priority Services (prioritizes cell phone), Government Emergency Telecommunications Services



(landline), Telecommunications Service Priority (repair and installation of communications circuits)

- Cybersecurity Advisor Program: will come in and assess, promote best practices, build, education, listen and coordinate.

- 2. Lineage Logistics Fire Brief Chief Scott Lo Parco, BCFPD#1
 - There has been a large fire at Lineage Logistics ½ a million square feet.
 - They have lots of machines out there working on demolition.
 - There is lots of air monitoring happening as well as distribution of masks, air filters and fans.
 - This started April 21st at around 5:15 a.m. This is a complex situation.
 - Product was packaged in corrugated cardboard, wrapped in plastic and then on pallets (frozen vegetables).
 - 28,500 lbs of anhydrous on site, none was released. There is a permanent monitor out there.
 - A lot of people think that this was a chemical fire, not as bad as a house fire where there are mixed chemicals.
 - They offloaded the anhydrous offsite and followed the appropriate reporting guidelines.
 - Waste products are going: metal to Burbank, a lot is going to Arlington,
 WA and Boardman, OR.
